# Shri Uddhav Thakeray Jee Hon'ble Chief Minister. Govt. of Maharashtra

Dear, Visionary of Strong India! Cooperative Greetings and the Best Regards.

### HUMBLE APPEAL

Impress the Hon'ble Prime Minister on the Ordinance No.12 of 2020, called Banking Regulation (Amendment) Ordinance 2020 – Since Cooperation is a State Subject - To organize the Chief Ministers Conference to bring about Reforms in the Cooperative Sector – Till then the Bill may be postponed in presenting it in the Parliament.

The Government of India, had notified an Ordinance No.12 of 2020 which is aimed to amend the "Banking Regulation Act-1949". In this Ordinance Section 12(1), 45 and 56(v) are bypassing the State Cooperative Act. Since Cooperation is State Subject, Central Act can't bypass in this State subject.

Further the Cooperative Sector had to be reformed to compete with the Market economy. Hence at this occasion, we requested the Honble Prime Minister to organize the Chief Ministers Conference on the Cooperative Sector and till then the proposed Bill may be postponed in presenting it in the Parliament. You are well aware that another two Ordinances No, 10 of 2020 and No.11 of 2020, which are regarding to the Farmers, the Agriculture Produces and the Marketing. On these three Ordinances we had submitted an Appeal, which is attached here with,

## **BRIEF NOTE**

- 1. Sahakara Dharma Peetam is a pious organization, working for the propagating the Sahakara Dharma, which is the only one Dharma that makes the Man a human being, along with the economic self-reliant.
- 2. With the sincere efforts of Indian Political authority and the Farmers, India became self sufficient in the production of Food grains.
- 3. Now the time has come to the Farming community to reap the fruits.
- 4. For this process the "Agriculture Produces Processing and Marketing Cooperatives" are the best solution, by which the farmer gets the best price for his produce and shares in profit of his processing society, in due course of time he will commend the Market.
- 5. Instead of this process, the Govt. of India issued three Ordinances No.10,11 and 12 of 2020. The Ordinances enables the Multinational Companies ("Sponsor') to enter the Agriculture Produce and Marketing system.

### Effects of the Ordinances;

- > The present Agriculture Produce Marketing system (Agri. Marketing Committees) will be dismantled.
- The Poor farmer had no choice but to come to Agreement with the "Sponsor" (The Multinational Company) and sell his produce to him. The Farmer bargain power is weakened.
- > The State Government would lost its Income from the Agri. Market Committees (AMC).
- > After the farming agreement regarding the Agriculture Produces with the farmer;
  - a). they are exempted from any State Acts.
  - b) The Essential Commodities Act is not applicable to these farm agreement produces.
- The Cooperative banks will stay for the name sake, they are private Bank. If needed they act as Mediator between the Multinational and the Farmer.
- 6. In due course of time the whole Agriculture Production and Marketing system will come under the control of the Multinationals, **which makes India's Sovereign Authority is questionable?**

Therefore consider the above and kindly impress the Hon'ble Prime Minister for the Chief Ministers Conference.
