**VVV Programme - Launching of Farmers  
Clubs by Sahakara Sankshema Samithi (SSS)**

Please refer to the correspondence resting with your letter No. SSS/Rythu Clubs/25/2003 dated 24 March 2003 proposing launching of Farmers' Clubs by the Sahakara Sankshema Samithi (SSS). We are pleased to advise that you have our approval to launch 10 Farmers Clubs each in Nalagonda & Mahaboobnagar Districts during the year 2003-04.

Further, the above approval is subject to the following conditions :

- i) The proposed Clubs would be launched jointly by the SSS and the PACS or DCCB. The PACS or DCCB would give the requisite consent letter.
- ii) The proposed Clubs would not be used or allowed to undertake any political or trade union activity.
- iii) The selection of Volunteers would be done in accordance with our usual norms and PACS to be associated with the Clubs may also be consulted before selecting the Volunteers/launching the Clubs.
- iv) The proposed Clubs would strive for propagation of principles of "Development through Credit", inculcation of repayment ethics and eliciting peoples' participation to the process of development.

- v) The SSS/PACS may keep a record of Club-Village-wise date regarding the loan outstanding, deposits mobilised etc., prior to launching the Clubs and thereafter periodically update the same. Major activities undertaken by the Clubs may also be documented in order to assess the impact made by the Clubs.
- vi) The SSS may guide the Clubs to prepare an Action Plan for undertaking need based activities and achieve the objectives of VVV.
- vii) The SSS/PACS may advise and assist the Clubs to maintain attendance-cum-minutes register and document various activities undertaken by them.
- viii) The SSS may submit the half-yearly progress report to us indicating the various activities taken up by the proposed Clubs regularly. The concerned DCCB may also submit a quarterly progress report in respect of the Farmers Clubs so launched from time to time.

We shall be glad if you will discuss the matter with the concerned DCCB/PACS and furnish us the detailed schedule for launching the Clubs <sup>indicating</sup> branches/societies/villages to be covered during 2003-04 at an early date.
