Sub :- Submission of views through Resolutions of the seminar on the theme "Dist. Co-op. Central Banks in the present changing senario - necessary. action - Req. - Reg.

"SAHAKARA SAMRAKSHANA SAMITHI", an Association of persons having commitment to and faith in the Co.operative Ideology in Andhra Pradesh. The aims of the Sahakara Samrakshna Samithi is (1) to propogate the Co.Operative Ideology. (2) to strive for the protection of Co.Operative movement and the Co.Operative Institutions and (3) to provide an Ideological base, and assistance in building the Co. operative movement as people's movement.

Samrakshana Samithi believes that educating the people on Co.Operative ideology has to be done in Organisang them on the problems facing the Co.Operative Institutions and the movement. In the present market oriented, liberalised economy, the co-Operative economic way is the only protective measure for the small & marginal farmers and rural artisans from the un-slaughters of the MARKET ECONOMY.

In persuations of our efforts in strengthening of the Cd-operative movement a seminar, on the theme "The Dist.Co.Operative Central Banks in the present changing senario" has been conducted on 19-11-96 at Sundarayya Vignana Kendram, on the occassion of the 43rd All India Co.Op. Week Celebrations.

The A. P. State Co. Op. Bank President Shri. T. D. Janardhana Rao, gave keynote address and is the Chief Guest, Hyderabad District Co.Opp rative Central Bank President Shri. K. Rudra Reddy has presided over the

the Seminar has urged the Government of Andhra Pradesh
theough the Reservations, to take necessary action in strengethening
the State Co-Operative Movement on the following subjects

- 1. Implimentation of the Inbalance Scheme of the Central Government to strengthen the Primary Agrl. Co.Op. Societies (Pacs). The scheme of Central Government envisiges to bear the difficits between Liabilities and Assets of PACS, in the states, in the manner: Government of India 35%, State Government 25%, Central Banks 30%, Apex Bank 10%. The implementation of this Scheme is the only way to weed out the losses of PACS and strengthen ning them in A.P. Hence the Seminar has urged the Government of A.P. to implement the Scheme by alloting suitable Budgetery Funds.
  - 2. Interest Rebate: The state Government has implemented interest Rebate Scheme to the PACS, members, who have paid their loans intime in 1991-92, and 1994. The Government has paid the some amount but still an amount of & 13 crores has to be paid to PACS in the State. The Seminar has urged the Government to release the interest rebate amount immediately andsave the PACS.
  - 3. Debt Relief :- The Government has to be paid %.13.45 crores under Debt Relief to the Dist.Co.Op. Central Banks in the State. It is high time to release the Debt Relief amount in saving them further losses. The Seminar has urged the Government to release the debt relief amounts and strengthen DCCBs.
  - 4. PADB Losses: The merger of Primary Agrl. Development
    Banks in the Dist.Co.Operative Central Banks at the time of
    implementation of "single window" system in 1987, the DCCBs have
    bear the losses to the tune nearly 100 crores but Government has
    calculated half of it and paid major amount to DCCBs but still
    there is a pending of 8.6 crores. Hence the Seminar has request
    the Government to kindly release the amount to the Dist.Co.Op.
    Central Banks.
  - 5. Strengthening of Dist.Co.Op. Marketing Societies: A.P. has good infrastrutural facilities of having Godowns in many PACS. for marketing purposes of farmers. This facility has to be used to the best, by providing financial assistance to the Dist.Co.Op Marketing Societies. Hence at the larger interest of small & marginal farmers of PACS, Government should provide financial

assistance to the Dist.Co.Op. Marketing Societies in A.P.

Further The Seminar has appealed to the Government of India and to the Indian Co.operative movement, the Co.operative leaders and co.operative academicians to address themselves on the following resolutions.

- 1. The Dist.Co.operative Central Banks must be provided with Rehabilitation Funds to the tune of deficit in their Balance sheets on the implementation of the Prudential Norms issued by R.B.I. The Commercial Fanks, Rural Banks have already got the funds to get right their deficit in their balance sheets to the true of Rs.12,700 crores. Seminar has appealed to Govt.of India to provide Rs.10,000 crores in its 1997-98 Budget.
- 2. "Co.Operative sector" chapter must be incorporated in the ensuing 9th Five Year P-lan documents. The historical 1958 National Levelopment Counsel Resolutions must be looked into.
- 3. National Co.Operative Bank of India must be allowed to mobilise its resources and Dist. and Urban Co.Operative Banks deposits must be treated as S.L.R. deposits.
- 4. Insurance Co.Operatives must be permitted as and when the Insurance Sector is privatised, to serve their 16 crores members of the Indian Co.Operative movement.
- 5. National Co.Operative policy must be formulated and announced immediately.
- 6. Pending due amounts to the Dist. Co.Operative Central Banks under the ARDR scheme of 1989 along with interests losses must be MFR paid.
- 7. Private local Banks should not be permitted. It is an unethical and against the spirit of the Indian Independence struggle movement. And also against the objects of the Indian Co.Operative movement. The Dist. Co.Operative Central Banks bound to be dislocated with the entrance of the Private Local Banks.

The "Sahakara Samrakshana Samithi " request the Government of Andhra Pradesh to consider the above resolutions expressed in a Seminar and take necessary action to release the funds to the PACS and DCCBs and strengthen the Co.Operative movement.
